2022 HOSPITALITY RIDER

DRESSING ROOMS

Purchaser shall provide (3) large, comfortable and private Dressing Rooms. Dressing Rooms are for the exclusive use of Artist and Artist personnel only. Dressing room hospitality (catering) and towel requirements are specified in the Hospitality Rider.

Dressing rooms shall be CLEAN, DRY, WELL-LIGHTED, and HEATED or AIR-CONDITIONED as the weather shall require, Auxiliary heating or air-conditioning units must be provided if deemed necessary by Artist or her representative.

Dressing Rooms shall have lockable doors. There shall be ample dressing room area security to prohibit all unauthorized personnel from the Dressing Room area. A Security Guard shall remain at all entrances of Dressing Room prior to Artists’ arrival (times to be advanced by Security Director), during performance, and until all of Artist’s equipment has been removed from said Dressing Room.

SECURITY REQUIREMENTS

All matters of Security will be advanced by the Artists' Security Director. Any security issues or questions should be directed to the Artists' Security Director. Artists' Tour Manager, Production Manager, and Security Director shall have complete and exclusive supervision and control over access to the stage, as well as the deployment of security forces in such areas prior to and during **VANITY ROSE'S** performance. Purchaser shall provide at Purchaser's sole cost and expense the below listed security personnel:

Purchaser agrees to provide competent and licensed security and protection against all loss of musical and electronic equipment, road cases, and personal effects in dressing rooms and all backstage and stage areas. The Purchaser will be held responsible for the safety of the artists and road crew at all times. Security shall commence upon arrival of **VANITY ROSE'S** equipment at the venue and shall continue until all of Artist's equipment has been removed from the venue.

Security Meeting: Purchaser or his representative shall meet with **VANITY ROSE'S** Tour Manager, Production Manager, and/or Security Director at time to be advanced by **VANITY ROSE'S** Security Director or Tour Manager.

Promoter shall furnish Security Director or Tour Manager with Head of Security's name, contact phone number, pager numbers and fax numbers for advancement purposes. Promoter shall furnish Tour Manager and/or **VANITY ROSE'S** Security Director with full and complete diagrams of Venue including capacities, all entrances, exits, stairwells, fire extinguishers and electrical panels. Promoter shall provide six (4) Security Personnel in FRONT OF STAGE. Promoter shall provide two (2) Security Personnel (one man at each set of stairs to the stage or VIP area). Promoter shall provide one (1) Security Personnel at **VANITY ROSE'S** dressing room door.

ABUSE OF AUTHORITY

Tour Manager or Production Manager reserves the right to have removed from the premises and have relieved of his/her duties any person, security, or house staff who has been seen abusing their authority or using excessive violence to members of the general public or touring staff.

PURCHASER REPRESENTATIVE

PURCHASER agrees to furnish, at PURCHASER sole cost and expense, his personal representative (fully fluent in English and local language) who is capable of making any decisions pertaining to the engagement from the time of arrival of **VANITY ROSE'S** production personnel and or equipment (including outside staging materials) through to the time of departure. This representative must have copies of this entire agreement, together with any rider(s), copies of mailgrams, facsimiles and letters pertaining to this engagement.

PARKING (IF APPLICABLE)

Secured Parking spaces adjacent to Backstage Entrance should be made available for One (1) Custom Tour Coach with trailer, and 2 (two) Passenger Vans. If this is a one off date please secure 3 Parking Spaces backstage for **VANITY ROSE**. These spaces should be made available to the touring entourage from 6:00 am until the end of load out.

These parking spaces shall be as close to the stage door entrance as possible and not accessible to the general public. PURCHASER shall be responsible for all necessary parking permits and variances. Please make sure all parking permits are available well in advance of the required time to be distributed to the **VANITY ROSE'S** staff, support acts, etc. PURCHASER shall provide at PURCHASER'S sole cost and expense all shore power sources for tour bus. Power to the bus shall be available until **VANITY ROSE'S** Production Manager request's disconnection.

AIR TRANSPORTATION

PURCHASER shall provide EIGHT (8) round-trip, NON-RESTRICTED, "REFUNDABLE", DIRECT airfares (2 first class/ 6 coach) DELTA AIRLINES, window seats (Departure and Return to be announced). If tickets are not electronic ("E" tickets), tickets shall be delivered to Management a minimum of twenty-one (21) days prior to departure date. Airfare must be fully refundable and MUST be approved by **VANITY ROSE** or **VANITY ROSE'S** Management prior to confirmation. **VANITY ROSE** to be flown into the closest airport to the venue. Return flights are to be scheduled as early as possible BEFORE 12:00 PM on the departure date. Afternoon/ Evening return flights are not accepted unless pre-approved by **VANITY ROSE'S** Management. Purchaser agrees to reimburse **VANITY ROSE'S** all air travel related expenses (i.e. baggage fees up to \$25-75per bag). Travel party names and info will be provided after full execution of this agreement. Purchaser MUST book all travel through our travel agent of choice.

GROUND TRANSPORTATION

PURCHASER shall provide at PURCHASER'S sole cost and expense the below listed transportation, specifics to be advanced by Tour Manager:

Purchaser shall furnish One (1) BLACK 2021 or better model WITH CAPTAINS CHAIRS 7 passenger SUV's with tinted windows or One (1) JET PACKAGE SPRINTER Van. Vehicles must have a front seat for security.

These vehicles shall be supplied upon **VANITY ROSE'S** arrival, fully fueled with one driver only (no friends or additional passengers). These vehicles shall be for the sole use of **VANITY ROSE** and shall be made available to the Tour Manager at his request. Vehicles will remain with **VANITY ROSE** and management until dismissed. AT NO TIME SHALL **VANITY ROSE** BE WITHOUT THEIR ASSIGNED GROUND TRANSPORTATION AND DRIVER. PLEASE HAVE THE DRIVERS IN PROFESSIONAL ATTIRE

HOTEL ACCOMMODATIONS:

PURCHASER shall provide **VANITY ROSE** with:

One (3) King Suites**

Four (4) Non-Smoking King Rooms.

** SUITES SHOULD INCLUDE microwave & MINI FRIDGE

Hotel must not be less than a FOUR STAR hotel with 24-hr room service and WIFI. **VANITY ROSE'S** Management will not accept anything less and reserves the right to change rooms/hotel at Purchaser's expense. Rooms should be reserved for **VANITY ROSE** in the name in which is provided by Management in advance. No one is to know the suites of **VANITY ROSE**.

Reservations are to be paid in full, and verified 48 (72 hours international) hours prior to **VANITY ROSE'S** Management or **VANITY ROSE'S** arrival (whomever is due to arrive first), with all taxes, gratuities and WIFI fees paid. Rooms shall be guaranteed for early/late check-in and late checkout at 4pm. Any event that has a venue of performance

SPECIAL REGULATIONS

PURCHASER, prior to returning the contract to **VANITY ROSE** shall inform **VANITY ROSE** in writing of any mandatory union breaks, curfews, fire regulations minimum and maximum light level requirements, maximum sound level limits, requirements relating to the presence of uniformed police within the concert hall, and any other unique regulations or peculiarities (including but not limited to Union fees as to the filming or audio recording of the performance). Any regulation or peculiarity that ARTIST'S Production Manager decides will affect the smooth running of the show will be considered breach of contract by PURCHASER.
